

## **Busking in St Peter Port Permit Application Guide**

**Any persons interested in busking in St Peter Port are required to obtain a permit which is issued by the Constables of St. Peter Port.**

This guide explains how to apply for a **permit** and sets out a performance **code of practice** which has been developed in close association with Guernsey Arts and St. Peter Port Constables.

Guernsey Arts and The St Peter Port Constables are committed to adding vibrancy to the Town through the busking initiative and are keen to work with musicians, artists and entertainers to maximise this. We will take a proactive approach to communicating with Buskers.

Applicants are asked to consider their commitment to busking before applying as they are expected to commit to a minimum of 6 busking sessions per annum.

### **Permit Application procedure**

- **NEW** applicants wishing to obtain a permit will need to contact Guernsey Arts at Candie Museum, Candie Road, St Peter Port, telephone 01481 220713 or e-mail [Grace@arts.gg](mailto:Grace@arts.gg). Information can also be downloaded from [www.arts.gg](http://www.arts.gg)
- All approved applicants will receive their permit for that year from the Constables of St. Peter Port. Their names and contact details will be held by the Guernsey Arts and Constables of St. Peter Port for the year of that permit plus one extra year.
- Busking permits are not transferable and may be withdrawn if the code of practice set out is not followed.
- The issue of a permit is for one year starting from the first of January each year. The permit can be renewed on an annual basis. **Previously approved acts** are only required to verify that the information which they submitted in their original application form still applies, or in the event of any changes provide updated information.
- In the case of performing groups the permit will be issued in the name of the group leader thereby enabling the membership of the group to vary according to changing circumstances.
- Permits will be issued and posted from the Constables of St. Peter Port, Constables Office, Lefebvre Street, St. Peter Port. The office is open 9.30am – 1.30pm Monday and Friday, and 9am-4pm Tuesday, Wednesday, and Thursday.

### Designated Busking sites and timings

The permit will only be issued on condition that the acts are performed on **Monday – Saturdays** during the period **10 am until 7 pm** and in the following designated sites as per the attached map :-

- A Adjacent to Liberation Monument
- B La Plaiderie (opposite JB Parkers)
- C Le Pollet (to the side of Next, a cut in area)
- D Outside Guernsey Tourist Information Centre (courtyard area outside entrance)
- E Le Marchant Steps (half way up Smith Street, cut in on left).
- F High Street (outside Boots)
- G High Street (outside Creaseys entrance, where pavement cuts in)
- H Arcade Steps (in between Fletcher Sports and Dix Neuf)
- I Bottom of Market Steps (outside Lloyds Pharmacy)
- J Church Square (to the side of the Town Church entrance)
- K Outside Town Church (seaward side)
- L Market Square - for the avoidance of doubt the cobbled area is defined as the Market Square. It does not include any paved areas or Market Terrace or Market Street. Permit holders must contact Annie Rihoy of Bailiwick Estates on [Events@bailiwickstates.com](mailto:Events@bailiwickstates.com) in order to arrange a performance slot.
- M Market Street (in front of The Golden Lion)
- N Mill Street (any appropriate point along the street e.g. outside an unoccupied shop)
- O Outside Picquet House

### **Special note on Liberation Day, Seafront Sundays and other events in town.**

- Busking on Liberation Day is handled by the Liberation Day Working Group. Selected buskers with existing permits will be approached by the group. Submissions will not be considered.
- Guernsey Street Festival will run from 20th July – 3rd August 2024, during which time we would ask you to contact [participate@guernseystreetfestival.com](mailto:participate@guernseystreetfestival.com) in order to enquire about a performance slot.
- Busking is also permitted for Seafront Sundays – a schedule of the selected dates for the period May-September is available from Guernsey Arts. Specific sites and time slots can be arranged by contacting the relevant organiser for the day as per the schedule.
- Please ensure to contact the organisers of other events within town – there may not be an opportunity to busk, however there may be an option to arrange a performance slot. Guernsey Arts will circulate information where possible.

### **Code of Practice**

- Music or voice at all the above sites may be amplified but not to an unacceptable level. For amplification busking amps are recommended in all sites. **Please note that Legislation in Guernsey under the Noise Abatement Ordinance 1962** requires anyone wishing to use a PA/sound system outdoors to obtain a permit from the Office of Environmental Health & Pollution Regulation (details available via [www.gov.gg/papermits](http://www.gov.gg/papermits)).
- Performances of no longer than 60 minutes duration are recommended at all sites.
- Equipment and any personal effects must not be spread out so it obstructs pedestrians and care must be taken in the Market Square to avoid damage to the cobblestones.
- The areas must be left clean and tidy after each performance.
- The permit must be carried with the named Busker(s) at all times during the entertainment and must be presented if requested to do so.
- No sign can be displayed inviting payment except where a collection for charity has been authorised by the Parish Constables. Buskers are allowed to have a hat or case nearby that people may put money in if they wish as well as sell recordings of their own (and only their own) performances.
- Buskers shall not say anything which is likely to cause alarm, distress, or offence to members of the public. If the complaint is about excessive noise it may be possible for the busker to reach a compromise by reducing their noise level.

### **Special note: Public Liability Insurance Cover**

- All permit holders are required to have Public Liability Insurance cover of £2.5 million. The Sport & Culture Department will provide this cover for those who do not have their own insurance.
- **The States of Guernsey will not accept any liability should any injuries be sustained to the permit holder or members of the public.**

### **Performers aged under 18**

- For those aged under 18, a Busking in St. Peter Port Parental Consent form will need to be completed by a parent or guardian. We do not recommend young people under the age of 16 taking part without an adult present. The Guernsey Arts Commission or St Peter Port Constables will not be providing supervision for under 18s to take part. Parents and guardians therefore should make arrangements for their children to be supervised during this activity if they deem it necessary.
- If the act comprises of multiple young people, consent forms will need to be completed by a parent or guardian for each young person who will participate.
